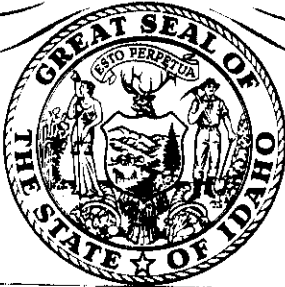

CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho do hereby certify that the original of the articles of incorporation of

ROCH, INC.

was filed in the office of the Secretary of State on the **Twenty-Ninth** day of **January**, A.D. One Thousand Nine Hundred **Sixty**, and duly recorded on Film No. **110** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at

Caldwell, in the County of **Canyon**.

ARTICLES OF INCORPORATION

OF

KOCH, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being natural persons of full age and citizens of the United States of America, in order to form a corporation for the purposes hereinafter stated pursuant to the Business Corporation Act of the State of Idaho, do hereby certify as follows:

I.

The name of this corporation is: Koch, Inc.

II.

The purposes for which this corporation is formed are:

(a) To conduct a general dry cleaning and dyeing business and all its branches.

(b) To conduct a general laundry business and all its branches.

(c) To acquire by purchase or lease, or otherwise, lands and interest in lands and to own, hold, improve, develop and manage any real estate so acquired and to erect or cause to be erected on any lands owned, held or occupied by the corporation, buildings or other structures with their appurtenances, and to rebuild, enlarge, alter or improve any buildings or other structures now or hereafter erected on any lands so owned, held or occupied, and to mortgage, sell, lease or otherwise dispose of any lands or interests in lands and in buildings or other structures, and any stores, shops, suites, rooms or parts of any buildings or other structures at any time owned or held by the corporation.

(d) To purchase, subscribe for, or otherwise acquire and own, hold, use, sell, assign, transfer, mortgage, pledge, exchange, or otherwise dispose of personal property of every kind and description, including shares of stock, bonds, debentures, notes, evidences of indebtedness, and other securities, contracts, or obligations of any corporation or corporations, association or associations, domestic or foreign, and while the owner or holder of any such personal property, stocks, bonds, debentures, notes, evidences or indebtedness or other securities, contracts, or obligations, to receive, collect, and dispose of the interest, dividends and income arising from such property, and to possess and exercise in respect thereof, all the rights, powers and privileges of ownership, including all voting powers on any stocks so owned.

(e) To purchase, hold, sell and transfer the shares of its own capital stock; provided, it shall not use its funds or property for the purchase of its own shares of capital stock when such use would cause any impairment of its capital; and provided further that the shares of its own capital stock owned by it shall not be voted upon directly or indirectly.

(f) To enter into, make, perform and carry out contracts of every sort and kind which may be necessary or desirable for the furtherance of the business of this corporation, with any persons

2 pality of the United States or any foreign country, government or
body politic.

3 (g) To adopt, apply for and register, purchase, lease
4 or otherwise acquire and to use, maintain and protect and to sell,
5 assign or grant licenses or other rights in respect of any trade
marks, trade names, patents, patent rights, copyrights, inventions,
formulas, processes and rights analogous thereto.

6 (h) To borrow money for any purpose of this corporation,
7 without limit as to amount, and to issue bonds, debentures, notes
8 or other evidences of indebtedness, secured or unsecured, of this
9 corporation for the moneys so borrowed, or in payment for property
10 acquired, or for any other objects or purposes of this corporation,
or in connection with its business; to secure payment of such deb-
entures, notes or other obligations by mortgages or deeds of trust
or pledges or other liens upon any or all of the property of this
corporation wheresoever situated.

11 (i) To carry out all or any part of the foregoing objects,
12 or purposes as principal or agent, or otherwise, either alone or in
13 conjunction with any person, association or other corporation and
14 in any part of the world; and in carrying on its business and for
15 the purpose of attaining or furthering any of its objects or pur-
16 poses, to make and perform such contracts of any kind and description,
to do such acts and such things and to exercise any and all such
powers as a natural person could lawfully make, perform, do or exer-
cise, provided that the same be not inconsistent with the objects
or purposes of this corporation, or the statutes of the State of
Idaho.

17 (j) To conduct its business in all or any of its branches
18 in the State of Idaho and in any and all other states, territories,
19 possessions, colonies and dependencies of the United States of
20 America, and in the District of Columbia, and in any or all foreign
countries, and to have one or more offices within or outside of the
State of Idaho.

21 (k) The objects as specified herein shall, except as
22 otherwise expressed, be in no way limited or restricted by reference
23 to or inference from the terms of any other clause or paragraph of
these articles. The objects, purposes and powers specified in each
of the clauses or paragraphs in these articles shall be regarded as
independent objects, purposes and powers.

24 The foregoing shall be construed as objects and powers and
25 the enumeration thereof shall not be held to limit or restrain in
26 any manner the general powers now or hereafter conferred on this
corporation by the Statutes of the State of Idaho.

27 III.

28 The period of existence and the duration of the life of
29 this corporation shall be perpetual.

30 IV.

31 The location and post office address of the registered
32 office of this corporation in the State of Idaho shall be Caldwell,
in the County of Canyon, State of Idaho.

V.

This corporation is authorized to issue one class of shares of its capital stock to be designated as "Common Stock." The total number of shares of common stock which this corporation shall be authorized to issue is 1,000. The aggregate par value of the common capital stock of this corporation shall be \$100,000.00; and the par value of each share of the common capital stock shall be \$100.00.

VI.

The names and post office addresses of each of the incorporators of this corporation and the number of shares of said common capital stock subscribed by each of these incorporators are as follows:

Each of the persons above enumerated as incorporators is a natural person over the age of 21 years and is a citizen of the United States of America.


VII.

The capital stock of this corporation shall be non-assessable; and the private property of the shareholders of this corporation shall not be liable for the debts, obligations or liabilities of this corporation.


VIII.


A director of this corporation shall not be required to be a holder of any of the shares of the common capital stock of the corporation.


