Articles of Incorporation

of

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, acting as incorporators of a non-profit corporation, organized under and pursuant to the Idaho Non-Profit Corporation Act, being of a legal age and residence of the United States, for purposes of forming a non-profit corporation, this day voluntarily associated ourselves together and hereby agree as follows and adopt the following Articles of Incorporation:

I.

NAME

The name of the corporation shall be **SWEET COMMUNITY IMPROVEMENT BOARD, INC.**

II.

PURPOSE OF CORPORATION

A. The corporation is organized for the purpose of purposes of conducting any and all lawful activity for which non-profit corporations may be incorporated in the state of Idaho.

B. To exercise all powers granted by law necessary and proper to carry out the above-stated purposes, including, but not limited to, the power to accept donations of money, property, whether real or personal, or any other thing of value. Nothing herein contained shall be deemed to authorize or permit the corporation to carry on any business for profit, to exercise any power, or to do any act that a corporation formed under the Act, or any amendment thereto or substitute therefor, may not at the time lawfully carry on or do.

C. Charitable, religious, educational, public safety, or literary purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended from time to time, including, for such purposes, the making of distributions to organizations that qualify as exempt corporations under Section 501 (c)(3).

VII.

MEMBERSHIP

The incorporation shall have no members. All provisions regarding membership in the corporation shall be contained in the by-laws of the corporation.

VIII.

DISTRIBUTION OF ASSETS ON DISSOLUTION

Upon dissolution of the corporation, the board of directors shall, after paying or making provision for the payment of all liabilities of the corporation,

distribute all the assets of the corporation consistent with the purposes of the corporation to such organization or organizations as shall at the time qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time, in such manner as the board of directors shall determine. Any such assets not so distributed shall be distributed by the district court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as such court shall determine to be consistent with the purposes of the corporation.

IX.
LIMITATIONS

No part of the net earnings or the assets of the corporation shall insure to the benefit of, or be distributable to, its members, directors, officers, or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time.

X.
DURATION

The period of duration of the corporation is perpetual.
