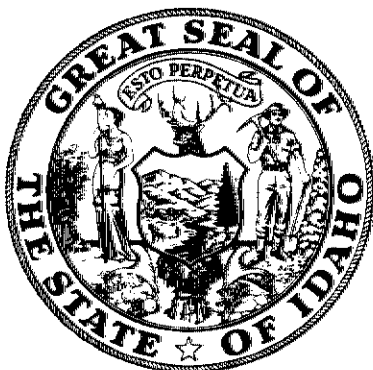

ARTICLES OF INCORPORATION
OF
SENEACQUOTEEN CEMETERY ASSOCIATION, INCORPORATED

KNOW ALL MEN BY THESE PRESENTS, that we, HARRY KENNY, ROBERT MEADOWS, EDGAR BELL, FLOYD BUTTS and ARNOLD BLOOD, all of Bonner County, State of Idaho, and each of whom is a bonafide resident of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho:

AND WE DO HEREBY CERTIFY:

I

That the name of this corporation is the SENEACQUOTEEN CEMETERY ASSOCIATION, INCORPORATED.

II

That the agent and place where its principal business is to be carried on is Harry Kenny, Route 1, Box 278, Priest River, Idaho, 83856, in Bonner County, Idaho.

III

That the time for which this corporation shall exist will be in perpetuity, from and after the date of its incorporation.

IV

That the number of directors of said corporation shall be five (5).

V

That said corporation shall have no capital stock, and said corporation is formed as a non-profit, cooperative association.

VI

That the rights and interest of all members in such corporation shall be equal and no member shall have or acquire a greater interest therein than any other member.

Such corporation shall issue membership certificates to each member thereof, which said membership certificates cannot be assigned so that the transferee thereof can, by such transfer, become a member of the association except by resolution of the Board of Directors and under such regulations as the By-Laws may prescribe.

VII

The following named persons shall act as directors of the corporation until the first annual meeting of the corporation, and until their successors are elected and qualified, namely Harry Kenny, Robert Meadows, Edgar Bell, Floyd Butts, and Arnold Blood.

VIII

A member of this corporation shall not be personally liable for the debts of the corporation or any portion thereof in excess of the amount remaining unpaid, if any, upon his membership fee or annual dues.

IX

The objectives and purposes for which this corporation is formed are as follows:

To purchase, own and hold real estate and any interest in real property. To improve real property for the uses and purposes of the corporation. To sell and dispose of and to issue contracts of sale and deeds evidencing title to real property. To cause cemetery property to be surveyed and platted. To care for such cemetery property for hire or otherwise. To sue or to be sued in any Court as a natural person may. To enter into any contract or obligation essentially necessary or proper to the transaction of its business as a cemetery association and to do all and everything requisite and necessary to be done in order to

successfully carry out all its objectives and purposes above enumerated.

X

This corporation shall have the right to amend these Articles of Incorporation at any time, by a two-thirds vote of the members of said corporation and in accordance with the laws of the State of Idaho now in force, or as may be hereafter provided.
