

Know all men by these Presents:

That the undersigned have this day associated themselves together for the purpose of forming a corporation under the Laws of the State of Idaho, and we do now declare and certify our Articles of Incorporation, and we do hereby accept the constitution of the State of Idaho.

First.

The name of the corporation shall be:-

The Wake-up-Jim Gold Mining Company.

Second.

The purposes for which this corporation is formed are the mining, milling, reducing, crushing, and refining of gold and silver ores, copper ores, and ores containing other precious metals, and buying, selling and mortgaging of mining properties. The construction and erection of such Smelting, milling, reduction, and mining plants, Chlorination, Cyanide, Hydraulic, dredging or other plants, as may be necessary in the reduction of the ores and auriferous gravels taken from the property owned or under bond & lease to the corporation, or bought or procured from other sources.

The construction and operation of such railways, tramways, flumes, ditches, and pipe lines, or other modes of conveyance, and transportation, as may be necessary in the treatment and transportation of the ores and auriferous gravels, and mining materials and all kind of mining supplies, or in the transportation of the said ores or gravels or mining materials and supplies from the mines to the mills, and to the market, and from the mills or from the market to the mines.

The purchasing, leasing and holding of such water

rights, flumes, ditches, pipe lines or other water supply, or water courses, as may be necessary for the carrying on of the business aforesaid.

The construction of such engine houses, electric plants, water ditches, flumes, pipe lines, or water power as may be necessary to carry on the business of mining and reducing ores and auriferous gravels, and the transportation of material and supplies aforesaid.

To carry on a general business of mining and transportation of material and supplies, and producing ores and to hold such property, and to construct such machinery and workings, and ^{to} do and perform all such acts as may be necessary and incident to a general mining business, and transportation of mining materials and supplies.

To buy, sell, and lease properties, or ores and mining supplies, material, and machinery, and to convey the same to market, and to prepare the same for market, to locate Mining Claims, to buy, prospect, or lease mines or mining properties, and mining supplies, to exchange the same, to reduce ores for hire, to purchase all kind of ores containing precious or other metals. To advance money for prospecting, developing, or equipping mines, and transportation of all kind of material and supplies, and for the expenses incident thereto

Third

The place where the principal business of this corporation shall be transacted shall be in the Village of Delta, County of Shoshone, State of Idaho, and the company may have branch offices at other places in the United States and Dominion of Canada or in any foreign country.

Fourth

The term for which this corporation ^{shall exist} shall be Fifty years.
