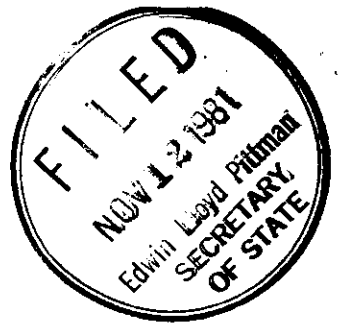

ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF

FMC MINERALS, INC.

Pursuant to the provisions of Section 61 of the Mississippi Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of this corporation is FMC MINERALS, INC.,
henceforth to be known as FRM MINERALS, INC.

SECOND: The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on November 5, 1981, in the manner prescribed by the Mississippi Business Corporation Act:

Amendment No.1

The title of the Articles of Incorporation shall henceforth read as follows:

"ARTICLES OF INCORPORATION
OF
FRM MINERALS, INC.

Amendment No. 2

The "First" Article of the Articles of Incorporation shall henceforth read as follows:

"First: The name of the corporation is FRM MINERALS,
INC."

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 100; and the number of shares entitled to vote thereon was 100. The corporation does not have any other class of stock.

FOURTH: The number of shares voted for such amendment was 100; and the number of shares votes against such amendment was 0.

FIFTH: The amendment does not change the amount of stated capital of the Corporation.
