ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION

OF

SAWTOOTH RADIO CORPORATION

An Idaho Corporation

WHEREAS, Sawtooth Radio Corporation, was organized under and by virtue of the laws of the State of Idaho on the 18th day of October, 1966; and,

WHEREAS, on the 17th day of February, 1969 the Articles of Incorporation of said Corporation, upon proceedings duly had, were amended so as to increase its capitalization to 1,000 Shares of no par value stock;

NOW, THEREFORE, We the undersigned, A. R. Spaulding, President; Warren B. Murphy, Vice President; and, Clarence N. Layne, Secretary-Treasurer of said Sawtooth Radio Corporation, organized and existing under and by virtue of the Laws of the State of Idaho, do hereby certify as follows:

Said A. R. Spaulding is President of said corporation, and the said Warren B. Murphy is Vice President of said corporation; and, Clarence N. Layne is the Secretary-Treasurer of said corporation.

At a regularly and duly called Annual Meeting of the Stockholders of said corporation, upon Notice duly and regularly given according to the Laws of the State of Idaho and the By-Laws of said Corporation; with specific notice of the increase of the capitalization of said corporation from 200 Shares of no par value stock to 1,000 Shares of no par value stock, which

expressly stated the impending amendment of the Articles of Incorporation of Sawtooth Radio Corporation, which meeting was held on the 17th day of February, 1969 at the office of the Corporation at Klix Radio Station, Elizabeth Boulevard, Twin Falls, Idaho 83301.

There was present at the said stockholders meeting all of the voting power of the stockholders and all of the stockholders present, by a 0 vote NO and a 8 vote YES duly passes and adopted a Resolution amending the Articles of Incorporation of the Corporation, which Resolution is as follows:

"It is hereby moved that Article V of the Articles of Incorporation of Sawtooth Radio Corporation be amended to read as follows:

"V.

"That the amount of the authorized Stock of said Corporation shall be 1,000 Shares of common stock of no par value."

The President, Vice President and Secretary-Treasurer of said corporation were at said meeting of the stockholders; that at said meeting they were duly authorized and directed to make, verify and file such certificates and other papers and documents as may be necessary or required by the laws of the state of Idaho to carry into effect the changes adopted by the Corporation by amendment to its Articles of Incorporation; and,

We do hereby certify that the following is a full and true and correct copy of the said Articles of Amendment of said Articles of Incorporation of Sawtooth Radio Corporation,

an Idaho corporation; to-wit:

V.

That the amount of the authorized stock of said corporation shall be 1,000 Shares of common stock of no par value.

All of the shareholders were represented either in person or by proxy at said meeting and duly voted upon the foregoing Amendment to Articles of Incorporation of Sawtooth Radio Corporation, an Idaho corporation.
