Pursuant to the provisions of the Idaho Business Corporation Act, the shareholders of Home Helpers, Inc. adopted the hereinafter stated amendments to its Articles of Incorporation and in consequence thereof, these Articles of Amendment are being executed in accordance with Idaho Code §30-1-61.

The following amendments to the Articles of Incorporation were adopted by the shareholders of the corporation on the 1st day of February, 1986, in the manner prescribed by the Idaho Business Corporation Act:

1. Article I of the Articles of Incorporation of Home Helpers, Inc., was amended to read as follows:

ARTICLE I
NAME

The name of the corporation shall be Alpha, Inc.


