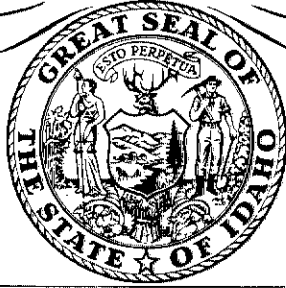

2 (d) To deal in commercial paper, negotiable and non-negotiable
3 instruments, documents of title, investment securities, accounts and
4 contract rights, chattel paper, documents and instruments, general
5 intangibles, goods, consumer goods, equipment, farm products, and
6 inventory, and choses in action of all kinds, both as principal and as
7 agent; also to buy and sell liens on real and personal property and to loan
8 money and accept as surety therefor liens on and pledges of real and
9 personal property; to act as agent or attorney for the transaction of any
10 business or the management of the estates or the collection of rents,
11 accounts, interest, dividends, notes, and bonds, securities for money,
12 and demands of every kind and character; and to also act as agent or
13 trustee for persons and corporations in any and all other matters which
14 can be solicited, negotiated, operated, and carried on by an agent or
15 trustee; also to act as agent or broker in securing loans effecting sales of
16 real and personal property; to organize, finance, develop, and improve
17 business firms, partnerships, and corporations.

18 (e) To purchase, lease and otherwise acquire, hold, lease,
19 sell, assign, transfer, pledge, exchange, mortgage, convey, and otherwise
20 dispose of real property of every kind and description within and without
21 the State of Idaho, and in any part of the world.

22 (f) To act as insurance broker or agent for insurance companies
23 in soliciting and receiving applications for insurance of all kinds and classes
24 including but not limited to credit life insurance, accident and health
25 insurance in connection with commercial paper and deferred balance
26 contracts with respect to and covering any or all of the items mentioned in
27 subparagraph (a) hereof; and in collecting and receipting for premiums on
28 such insurance written by insurance companies; to do such other acts as are
29 necessary or customary in such brokerage or agency and which may be
30 delegated to it by insurance companies, and to receive commissions for
31 its services as broker or agent.

32 (g) To borrow money and otherwise obtain credit for the account

1 of said corporation and to issue debentures or other evidences of indebted-
2 ness therefor and to obligate the assets of the corporation as security for
3 such indebtedness; to act as surety and guarantor in any and all types of
4 engagements including the power to execute, endorse, and deliver contracts,
5 and to guarantee the prompt and faithful performance and payment of debts,
6 notes, agreements, contracts, and undertakings of any other person, firm,
7 partnership, or corporation; and including also the power to act as an
8 accommodation, co-maker or guarantor of obligations either as primary
9 or secondary obligor.

10 (h) To buy, sell, deal in, and operate any real or personal
11 property, or to carry on any other business that may be of convenience
12 or advantage in carrying on any of the activities authorized in the foregoing
13 paragraphs.

14 (i) The foregoing clauses shall be construed both as objects and
15 powers and it is hereby expressly provided that the enumeration herein of
16 specific objects and powers shall not be held to limit or restrict in any
17 manner the general powers of this corporation and all the powers and
18 purposes hereinbefore enumerated shall be exercised, carried on, and
19 enjoyed by this corporation within the State of Idaho and outside of the
20 State of Idaho to such extent and in such manner as corporations organized
21 under the General Corporation Laws of the State of Idaho may properly and
22 legally exercise, carry on, and enjoy.

23 III.

24 That this corporation shall have perpetual existence.

25 IV.

26 That the registered office of said corporation in the State of Idaho
27 shall be located in Rupert, in the County of Minidoka, and that the post
28 office address of the registered office of said corporation shall be
29 P. O. Box 96, Rupert, Idaho 83350.

30 V.

31 That the authorized capital of said corporation shall consist of
32 five hundred (500) shares of common stock of a par value of One Hundred
Dollars (\$100.00) each, making the total aggregate par value of the authorized





1 capital shares of this corporation Fifty Thousand Dollars (\$50,000.00).

2 VI.

3 That the amount of capital stock of said corporation which has
4 been actually subscribed is Four Hundred Dollars (\$400.00), and that the


