That I, the undersigned, being a natural citizen of the United States of Idaho, and majority, have this day and do hereby voluntarily associate for the purpose of forming a corporation under the laws of the State of Idaho, and I do hereby certify:

ARTICLE I.



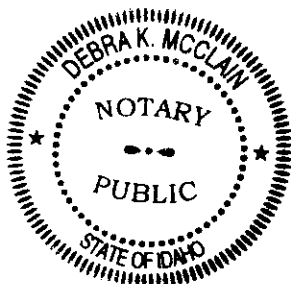
