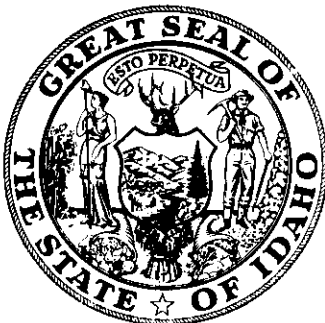

Pursuant to the provisions of §§30-1-58 through 30-1-62 of the Idaho Business Corporation Act, the undersigned corporation adopts these Articles of Amendment to its Articles of Incorporation:

Section 1. The name of the corporation is GEM STATE PLUMBING, INC.

Section 2. The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on September 27, 1994, in the manner prescribed by the Idaho Business Corporation Act:

ARTICLE I.

The name of the corporation shall be:

GEM STONE INVESTMENTS, INC.

Section 3. The number of shares of the corporation outstanding at the time of the adoption of the amendment referred to above was 88.24. The number of shares entitled to vote thereon was 88.24. All of the issued and outstanding shares at the time of the vote were of one class, and therefore there was no separate class voting on the amendment.

Section 4. The number of shares voted for such amendment was 88.24, and the number of shares voted against such amendment was 0.

Section 5. The amendment does not provide for an exchange, reclassification or cancellation of issued shares.

Section 6. The amendment does not effect a change in the amount of stated capital.
