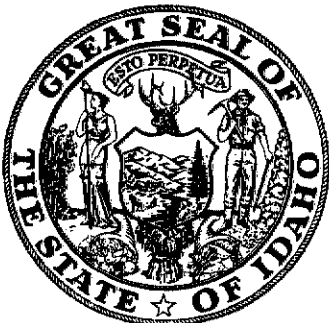

# ARTICLES OF INCORPORATION of HARRIS HOMES, INC.

The undersigned incorporator(s), desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopt(s) the following articles of incorporation:

## ARTICLE ONE Name

The name of the corporation is Harris Homes, Inc..

## ARTICLE TWO Purposes

The purpose of the corporation is to engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

## ARTICLE THREE Duration

The period of duration of the corporation is perpetual.

## ARTICLE FOUR Registered Office and Agents

The address of the corporation's initial registered office in the State of Idaho is 2296 George Lane, City of Post Falls, County of Kootenai, Idaho. The name of the corporation's initial registered agent at such address is Michael P. Harris.

## ARTICLE FIVE Stock

The total authorized number of par value shares of stock is none. The aggregate par value of the total authorized number of par value shares is No Dollars (\$0.00). The total authorized number of shares without par value is 1,000.

The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than four persons. Stock shall be issued and transferable only to natural persons who are not nonresident aliens.
