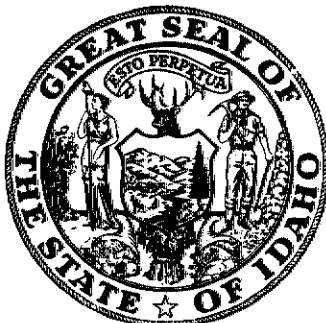

ARTICLES OF INCORPORATION

of

KNOWN ALL MEN BY THESE PRESENTS: That the undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of this corporation is ToxLab, Inc.

ARTICLE II

The objects and purposes for which this corporation are formed are:

The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The corporation shall have perpetual existence.

ARTICLE IV

The location and address of the registered office of the corporation shall be and is: 1090 Boeing Street, Boise, Idaho 83705. The name and address of the registered agent is McCoy (Mick) E. Looney, 1090 Boeing Street, Boise, Idaho 83705.

ARTICLE V

The amount of the capital stock of the corporation that is authorized to be issued is 10,000 shares and each share shall have no par value. Said stock shall be and is non-assessable.

ARTICLE VII

The private property of the stockholders of the corporation shall not be subject of the payment of corporate debts to any extent whatever, and the shares of the corporation shall not be subject to assessment for the purpose of paying expenses, conducting business or paying debts of the corporation.

ARTICLE VIII

The number of directors constituting the initial board of directors of the corporation is two whose names and addresses are:

The above named persons shall serve as directors until the first annual meeting of shareholders or until successors be elected and qualified.

ARTICLE IX

The corporation of ToxLab, Inc. shall consist of McCoy (Mick) E. Looney, President and Treasurer and Jamalee K. Looney as Vice-President and Secretary. The President, McCoy (Mick) E. Looney, shall be issued 500 shares of common stock on 1 February 1995; Jamalee K. Looney will be issued 250 shares of common stock on the same date; Blake Nathaniel Looney and Alexandria Nicole Looney will each be issued 50 shares of common stock on the same date.

ARTICLE X

No contract or other transaction between the corporation and any other corporation and no act of the corporation shall in any way be affected or invalidated by the fact that any off the directors or shareholders of the corporation are pecuniarily or otherwise interested in or are directors or officers of such other corporation; any directors, individual or any firm of which any directors or shareholder may be a member, may be a party to or may be pecuniarily or otherwise interested in any contract or transaction of the corporation provided the fact that he/she or such firm is do interested shall be disclosed or shall have been known to the Board of Directors or shareholders of the corporation which shall authorize any such contract or transaction with like force and effect as if he/she were not such officer or director of such other corporation or not so interested.


ARTICLE XI

The personal liability of a director/shareholder to the corporation or its stockholders for monetary damages for breach of fiduciary duty as director/shareholder is hereby eliminated and no director/shareholder shall have personal liability to the corporation or its stockholders for monetary damages for breach of fiduciary duty as a director/shareholder, except that the personal liability of a director/shareholder to the corporation or its stockholders for any breach of the directors/shareholders duty of loyalty to the corporation or its stockholders, for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law shall not be eliminated and the personal liability of a director/shareholder to the corporation of its stockholders for the

liability imposed by Idaho Code 30-1-48 shall not be eliminated and the personal liability of a director/shareholder to the corporation or its stockholders for personal liability for any transaction from which the director/shareholder derived a legally improper personal benefit shall not be eliminated.
