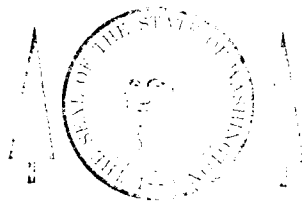

ARTICLES OF AMENDMENT  
OF  
BUSINESS FINANCE COMPANY, INC.

The name of Business Finance Company, Inc. is changed to Pacific National Investment Company by reason of the adoption of the resolution hereinafter set out at a stockholders meeting duly held for that purpose on the 24th day of November 1969, and the registered office of the corporation is changed from North 2015 Monroe, Spokane, Washington to South 165 Howard, Spokane, Washington by reason of the adoption of the resolution hereinafter set out at the same stockholders meeting held for that purpose, to wit:

"BE IT RESOLVED that Article I of the Articles of Incorporation of this company be amended to read as follows:

"ARTICLE I. The corporate name of this corporation shall be PACIFIC NATIONAL INVESTMENT COMPANY."

"BE IT RESOLVED that Article III of the Articles of Incorporation of this company be amended to read as follows:

"ARTICLE III. The address of the registered office of the corporation is: South 165 Howard, Spokane, Washington, and the name of its registered agent at such address is: WAYNE E. GUTHRIE."

The number of outstanding shares of the corporation is 250,000 and all said outstanding stock voted in favor of said amendments.
