The undersigned, acting as the sole incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such Corporation:

FIRST: The name of the Corporation is AGL, Inc.

SECOND: The period of the Corporation's duration is perpetual.



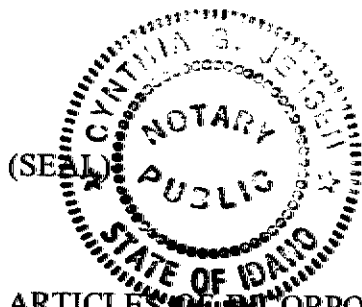
