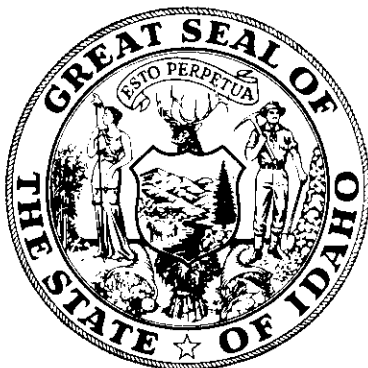

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being of full age and citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho.

We do hereby certify:

ARTICLE I

The name of the corporation is B B B, INC.

ARTICLE II

The duration of the corporation shall be perpetual.

ARTICLE III

The corporation is formed for the purpose of the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho.

#### ARTICLE IV

The corporation shall have the authority to issue FIFTY THOUSAND (50,000) non-assessable common shares at a par value of ONE DOLLAR (\$1.00) per share.

#### ARTICLE V

The name of the initial registered agent and initial registered office is JAMES BAXTER, JR., 2101 N. 23rd Street, Boise, Ada County, Idaho, 83702.

#### ARTICLE VI

The number of directors constituting the initial Board of Directors shall consist of FOUR (4), who will serve as directors until the first annual meeting of shareholders or until their successors be elected and qualify.


