## ARTICLES OF INCORPORATION.

## KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, do hereby associate ourselves together for the purpose forming a private corporation under the laws of the State of Idaho, and we hereby sertify and adopt the following Articles of Incorporation:

- 1. The name of the corporation is THE HAYS COLD MINING AND DEVELOPMENT COMPANY, and its principal place of transacting business is in Grangeville, Idaho.
- The purpose for which it is formed is, to carry on the business of mining, milling, smelting, extracting and treatings ores, metals and minerals, including quarts and placer mining, and to acquire mining property and mill-sites, and water-rights, by location, patent, lease, purchase or otherwise, in the State of Idaho and elsewhere, and to own, hold, develope, operate and dispose of the same; to locate, patent, purchase, lease or otherwise acquire deposits of marble, limestone, sandstone, clay, asbestos, coment and other stone valuable for building purposes, in the State of Idaho and elsewhere, and to manufacture and treat the same, and to sem, hold and develope, operate and dispose of such property; to losate, patent, louse, purchase, build, construct and otherwise acquire such power-sites, mill-sites, power plants, buildings, plants, tools and machinery; and to de all things incident to, or which may be necessary or convenient in operating or carrying out the objects and business of this corporation not incinsistent with law; to coll, lease, assign, transfer, mortgage or convey any rights and privileges, franchises, real or person property of the corporation, other than its franchise of being a corporation; to purchase, out, vote, sell or hypothecate the stocks and bonds of other corporations, and to borrow money, contrast debts and issue its notes, bonds or other obligations therefor, and to secure the payment of the same by mortgage or trust deed on or to any or all of the property of the corporation or otherwise not inconsistent with the laws of the State of Idaho.
- 3. The place where its principal business is to be transmitted in Grangeville, Idaho County, Idaho.

- 4. The term for which this corporation is to exist is Fifty Years from and after its incorporation.
- 5. The number of directors of the corporation shall be five who shall exercise, conduct and control the powers, business and property of the corporation; the directors shall be elected from among the stockholders of the corporation and shall hold their office for one year, or until the next annual meeting of the stockholders, and until their successors are elected and qualified in accordance with the by-laws of the corporation.
- The amount of the authorised capital stock of the corporation is Two Million Five Hundred Thousand Dollars, divided into Two Million Five Hundred Thousand Shares of the par value of One Dollar each, which shall be paid in, at such time as the Board of Directors may designate, in each, real or personal property, services, lease, option to purchase, or any other valuable right or thing, for the uses and purposes of the corporation, and all shares of capital stock, when issued in exchange therefor, shall thereupon and thereby become and be full-paid the same as though paid for in each at par, and shall be nonassessable ferever, and the judgment of the directors as to the value of any property, right or thing acquired in exchange for capital stock shall be conclusive.
