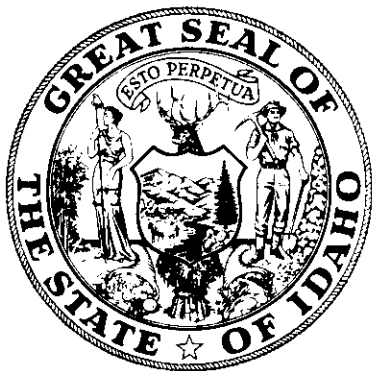

ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
CALDWELL TRANSPORTATION COMPANY, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is CALDWELL TRANSPORTATION COMPANY, INC.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on February 8, 1984, in the manner prescribed by the Idaho Business Act:

That Article IV of the Articles of Incorporation of Caldwell Transportation Company, Inc., be amended to read as follows:

"Article IV

STOCK. The aggregate number of shares which the corporation shall have authority to issue is 500. Said stock shall be of one class designated as common stock with a par value of \$100.00 per share."

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 100; and the number of shares entitled to vote thereon was 100.

FOURTH: The number of shares voted for such amendment was 100; and the number of shares voted against such amendment was -0-.

FIFTH: The manner in which such amendment effects a change in the amount of stated capital, and the amount of stated capital as changed by such amendment, are as follows:

The aggregate number of shares which the corporation shall have authority to issue was increased from 100 shares to 500 shares. The stated stock remained of one class designated as common stock

1 with a par value of \$100.00 per share, making the amount of stated
capital in the sum of \$50,000.00.
