The original certificate of limited partnership was executed by the partners on February 14, 1983 and filed in the office of the Idaho Secretary of State on March 10, 1983. An Amended and Restated Certificate of Limited Partnership was filed in the office of the Idaho Secretary of State on January 7, 1988, to document assignments made by Gordon E. Beckstead, a limited partner. The undersigned now wish to supplement the Amended and Restated Certificate of Limited Partnership because it incorrectly named Donald A. Jensen as a limited partner, when it should have named Jensen Family Trust as a limited partner.

The undersigned, therefore, supplement the amended and restated certificate of limited partnership as required by the laws of the State of Idaho and certify as follows:

FIRST: <u>The Name of the Partnership</u>. The name of the partnership is TFH, a Limited Partnership.

SECOND: The Character of the Business. The character of the business is to acquire, own, operate, improve, lease and sell real and personal properties acquired by the partnership, to acquire rights to the use of unimproved land and water rights for the purpose of constructing hydroelectric generation facilities and selling the electricity produced, and to engage in any and all other lawful business activities permitted under the laws of the State of Idaho.

THIRD: Agent and Principal Place of Business. The agent of the limited partnership shall be David M. Cooper. His address and the address of the principal place of business of the partnership is:

TENTH: Right of Substitution. Without the prior consent of the general partner, no limited partner may substitute an assignee as contributor in his or her place.

ELEVENTH: Admission of Additional Limited Partners. The general partner may admit one or more additional limited partners, which additional limited partners, unless donees of a part of the partnership interest of a general partner, shall be required, as a condition to being admitted as a limited partner, to contribute to the capital of the partnership such amount of cash or other marketable properties as may be necessary to avoid diluting the interests of the existing limited partners.

TWELFTH: <u>Priority of Limited Partners</u>. No right has been given to one or more of the limited partners to priority over other limited partners as to contributions, or as to compensation by way of income.

THIRTEENTH: <u>Continuation of Business</u>. Upon the death, adjudicated incapacity or retirement of the general partner, the remaining limited partners shall have the right to elect a new general partner and continue the partnership business or to wind up and liquidate the partnership.

FOURTEENTH: <u>Return for Contribution</u>. No limited partner has been given the right to demand and receive property other than cash in return for his or her contribution.


