ACCORDINGLY and by virtue of the authority vested in me by law, I issue this Certificate of Incorporation and attach hereto a duplicate original of the Articles of Incorporation.

We the undersigned individuals, acting as the incorporators of the corporation under the Idaho Nonprofit Corporation Act, adopt and do hereby certify the following Articles of Incorporation:

ARTICLES OF INCORPORATION 6 32

"Concerned Citizens for Education, Inc."

Article 1 - Name

The name of this corporation shall be "Concerned Citizens for Education, Inc."

Article 2 - Status

This corporation is formed as a non-profit corporation pursuant to the laws of the State of Idaho.

Article 3 - Duration

This corporation shall exist perpetually.

Article 4 - Initial Principal Office and Registered Agent

The initial registered agent and office of the corporation shall be: Kathy Dawes, 1018 East "E", Moscow, Idaho 83843.

Article 5 - Purpose

The purpose of this Corporation shall be to act as advocates for education in an effort to maintain and improve the quality of education at large.

Article 6 - Nonprofit Nature

This corporation is not organized and shall not be operated for the private gain of any person. No part of the assets, receipts or net earnings shall ever inure to the benefit of, or be distributable to, any individual.

Article 7 - Distributions of Assets Upon Dissolution

In the event of dissolution of this corporation, and after its just debts and obligations have been paid or provision has been made therefor, the remaining assets of this corporation, if any, shall be vested in a duly formed non-profit corporation, to be held as part of said corporation's general operating funds.

Article 8 - Status Under Federal Law

Notwithstanding any other provision of these Articles, this ARTICLES OF INCORPORATION - 1

corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal Income Tax as an organization described in Section 501 (c)(3) of the Internal Revenue Code of 1954 (as amended or as subject to prospective amendment.)

Article 9 - Powers

In furtherance of the foregoing purpose, and subject to the foregoing limitations on its organization and operations, this corporation shall have and may exercise all of the rights, powers, and privileges now or hereafter conferred upon nonprofit corporations organized under the laws of the State of Idaho.

Article 10 - Governance

The corporation shall be managed by a Board of Directors. Said Board will consist of the corporate officers and one chairperson of any standing committee established by the by-laws. The term of office shall be one year. The initial Board of Directors will consist of the following ten individuals who shall serve until their successors are duly elected by a majority vote of the voting members:

Unless changed by the by-laws, corporation officers shall be elected by the voting members to include a president, vice-president, secretary and treasurer. Chairpersons of the committees shall be chosen by the membership of each of the committees at the annual meeting. An officer shall not serve as a committee chair

Article 11 - Membership

Voting members are those who have paid current yearly dues. Other classes of membership including committee membership may be set forth in the by-laws.

Article 12 - Meetings

The Corporation shall meet annually and additional meetings may be called by the President. Reasonable notice shall be provided at least 2 weeks prior to the meeting time by publication in the CCE newsletter or newspaper of general circulation in Moscow, Idaho or by such other means.

Article 13 - Incorporator
