## ARTICLES OF INCORPORATION

OF

## RENT-ALL, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the Corporation is RENT-ALL, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the Corporation is organized is to carry on a video rental business together with all related activities and the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
