

### CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the

**CROWN TIRE SERVICE, INC. OF CALDWELL,**

a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the **Twenty-fourth** day of **February** **1966**,

original articles of amendment, as provided by Sections 30-146, 30-147, 30-148, 30-151 and 30-152, Idaho Code, merging **CROWN TIRE SERVICE, INC. OF BOISE** and **CROWN TIRE SERVICE, INC. OF NAMPA** with and into **CROWN TIRE SERVICE, INC. OF CALDWELL**, and changing name to:

**CROWN TIRE SERVICE, INC.,**

and increasing capital stock to \$75,000.00,

and that the said articles of amendment contain the statement of facts required by law, and ~~xxx~~ will be recorded on ~~microfilm~~ microfilm of Record of Domestic Corporations of the State of Idaho.

I THEREFORE FURTHER CERTIFY, That the Articles of Incorporation have been amended accordingly.

MERGER AGREEMENT

WHEREAS, CROWN TIRE SERVICE, INC., OF CALDWELL, an Idaho corporation (hereafter called the Caldwell corporation), and CROWN TIRE SERVICE, INC., OF NAMPA, an Idaho corporation (hereafter called the Nampa corporation), and CROWN TIRE SERVICE, INC., OF BOISE, an Idaho corporation (hereafter called the Boise corporation), are engaged in the business of buying and selling, at wholesale and retail, of rubber automotive tires and in conducting the general business of vulcanizing, reinforcing, rebuilding and repairing automotive tires, and

WHEREAS, each of said corporations, and their respective stockholders, would gain substantial benefits from a merger of CROWN TIRE SERVICE, INC., OF NAMPA and CROWN TIRE SERVICE, INC., OF BOISE with CROWN TIRE SERVICE, INC., OF CALDWELL, and

WHEREAS, the directors of each of said corporations desire to enter into a joint agreement prescribing the terms and conditions of merger, the mode of carrying the merger into effect, and any other necessary provisions,

NOW, THEREFORE, It is jointly agreed by the parties:

1. The Nampa corporation and the Boise corporation shall merge with the Caldwell corporation.

2. The Caldwell corporation shall amend its Articles of Incorporation so that its total authorized number of par value shares is increased from 500 shares of common stock to 1500 shares of common stock. The par value of each share shall remain at \$50.00 per share.

3. The Caldwell corporation shall amend its Articles of Incorporation so that its corporate name is changed to CROWN TIRE SERVICE, INC.

4. The shareholders of record for the Boise corporation and the Nampa corporation shall receive one share of stock in the Caldwell corporation for each share of stock they now hold in the Boise corporation or Nampa corporation.

5. After the merger, the number of directors of the Caldwell corporation shall be changed to five.

6. After the merger, the restrictions on transfer of stock shall be the same as existed in the shares of the Caldwell corporation.

7. Within thirty days after the merger, new directors and officers of the Caldwell corporation shall be elected in accordance with the By - Laws of the Caldwell corporation.

8. The By - Laws of the Caldwell corporation shall remain the same after the merger.

9. This agreement shall be submitted to the shareholders of each corporation at a meeting thereof, duly called separately in the manner provided in Section 30 - 133 Idaho Code for calling shareholders' meetings, and, if, at such meetings, the holders of two - thirds of the voting power of all shareholders of each corporation shall vote for adoption of said agreement, then that fact shall be certified on said agreement by the Secretary of each corporation, and the agreement so adopted and certified shall be signed by the President and Secretary of each corporation and acknowledged by the President of each corporation.
