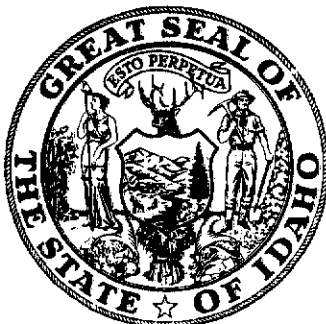

Articles of Amendment of the Articles of Incorporation of COMMUNITY HEALTH SERVICES, INC. are herein executed by said Corporation, pursuant to the provisions of the Idaho Business Corporation Act as follows:

1. The name of the corporation shall be changed to AUGUST HOME HEALTH, INC.
2. The amendments to the Articles of Incorporation of said corporation are as follows:

The FIRST Article of the Articles of Incorporation shall be amended to read as follows:

FIRST

The name of the corporation is AUGUST HOME HEALTH, INC. effective August 1, 1994.

The SECOND Article of the Articles of Incorporation shall be amended to read as follows:

SECOND

The location of the registered office of the corporation, in the state of Idaho is 2005 Ironwood Parkway, Suite #130, Coeur d'Alene, Idaho 83814.

The THIRD Article of the Articles of Incorporation shall be amended to read as follows:

THIRD

The name and address of the registered agent of the corporation is Linda Close, whose address shall be the same as the registered office of the corporation.

One hundred percent (100%) of the five hundred (500) outstanding shares all voted in favor of amending the First, Second, and Third Articles of Amendment of the Articles of Incorporation.
