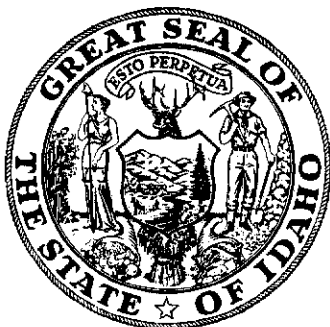

The undersigned, acting as incorporator of a corporation under  
the Idaho Business Corporation Act, adopts the following Articles  
of Incorporation for such corporation:

ARTICLE I.

The name of the corporation is Petterson Supply, Inc.

ARTICLE II.

The period of its duration is perpetual.

ARTICLE III.

The corporation is organized for the purpose of conducting and transacting any or all lawful business in the State of Idaho, and other states, including, but not limited to, buy, sell, trade, repair, lease, and deal in heating and air conditioning equipment and apparatus of all kinds and descriptions; to do everything necessary, proper, advisable or convenient for the accomplishment of the purposes hereinabove set forth, and to do all other things incident thereto or connected therewith, which are not forbidden by the Act, by other law, or by these Articles of Incorporation; to carry out the purposes hereinabove set forth in any state, territory, district or possession of the United States, or in any foreign country, to the extent that such purposes are not forbidden by the law of such state, territory, district or possession of the United States, or by such foreign country; and, in the case of any state, territory, district or possession of the United States, or any foreign country, in which one or more purposes are forbidden by law, to limit the purpose or purposes which the corporation

proposes to carry on in such state, territory, district or possession of the United States, or foreign country, to such purpose or purposes as are not forbidden by the law thereof in any certificate for application to do business in any such state, territory, district or possession of the United States, or foreign country.

#### ARTICLE IV.

The aggregate number of shares which the corporation shall have authority to issue is 50,000, which shares shall have \$1.00 par value.

#### ARTICLE V.

Provisions for the regulation of the internal affairs of the corporation are as shall be set forth in the Bylaws of the corporation as from time to time adopted or amended.

#### ARTICLE VI.

The address of the initial registered office of the corporation is 4577 Chinden Blvd., Boise, ID 83714, and the name of its initial registered agent at such address is Bart Petterson.

#### ARTICLE VII.

The number of directors constituting the board of directors of the corporation shall not be less than one, and the names and addresses of the persons who shall serve as the initial board of directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:

Each director and officer of the corporation now or hereafter serving as such, shall be indemnified by the corporation against any and all claims and liabilities to which he has or shall become subject by reason of serving or having served as such director or officer, or by reason of any action alleged to have been taken, omitted, or neglected by him as such director or officer; and the corporation shall reimburse each such person for all legal expenses reasonably incurred by him in connection with any such claim or liability, provided, however, that no such person shall be indemnified against, or be reimbursed for any expense incurred in connection with, any claim or liability arising out of his own willful misconduct or gross negligence. This indemnification is made pursuant to Idaho Code, §§ 30-1-48 and 30-1-54.

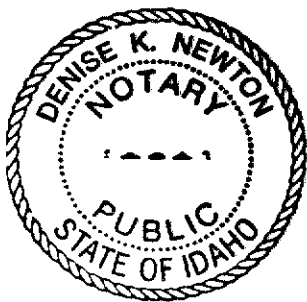
