### ARTICLES OF INCORPORATION E.S. PLENTY, LTD.

The undersigned natural persons of the age Roughtwenty-one years or more, acting as the incorporators under the Idaho Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I The name of the Corporation is: E.S. PLENTY LTD.. and its duration is perpetual

ARTICLE II The purpose for which the corporation is organized is:

Special loan and mortgage company, and to engage in any lawful activities for which corporations may be organized under the Idaho Business Corporation Act and amendments thereof and to do and perform and other lawful act for gain whether herein expressly set forth otherwise.

#### ARTICLE III

The Aggregate number of shares which the corporation shall have authority to issue is 25,000, each of which shall be common shares and shall have a par value of \$1.00 per share, this shall be issued as SECTION 1244 stock under the Internal Revenue code.

#### ARTICLE IV

Provisions for regulation of internal affairs of the corporation as may be appropriate and provided by the corporation By-Laws. The incorporating director does hereby subscribe to one share of said common stock

All the issued stock of all classes shall be subject to the following restriction on transfer permitted by Section 202 of the General Corporation Law.
