KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, James D. Mills, Garth D. Price, and Marilyn J. Mills, who are citizens of the State of Idaho and of the United States of America, and are bona fide residents of the State of Idaho, all of whom are of legal age, have this day voluntarily associated ourselves, and do by these ARTICLES OF INCORPORATION unite ourselves, for the purpose of forming a general business corporation under the laws of the State of Idaho, and we hereby certify:

I

The name of the Corporation shall be DEJURE', INCORPORATED.

ΊI

That the purpose for which said Corporation is formed are as follows:

(a) To engage in the manufacture of cosmetic and beauty aids. Sale, and distribution of said cosmetic and beauty aids, and generally to carry on any other business which can be advantageously carried on in conjunction with and incidental to any of the matters aforesaid.

(b) To excercise generally the powers customarily excercises by business corporations, and particularly the powers provided by the laws of the State of Idaho, referring especially to Section 29-114 Idaho Code, Annotated, in any State of the United States and throughout the world.

(c) To carry on any other business, or to do anything in connection with the objects and purposes above mentioned that may be necessary or proper to accomplish successfully or promote the said objects and purposes. The foregoing clauses, by reason the specific enumeration of powers, shall not be held to restrict the power of the corporation to do any of the things within the purview of its general purposes.

This corporation shall have perpetual existence.
