

Articles of incorporation of The Sub-Rosa Mining and Milling Company

Know all men by these presents
that we the undersigned have
this day associated ourselves together
for the purpose of incorporating under
the laws of the Territory of Idaho
a corporation to be known by the
corporate name of "The Sub-Rosa
Mining and Milling Company."

I

We hereby certify that the object
for which this corporation is
formed are:

To carry on and conduct the
business of mining on and extracting
metals of Gold and Silver from
those certain veins or lodes known
by the name of the "Sub-Rosa" vein or
lode, the "King of the Hills" vein or
lode and the "Golden Breath" vein
or lode, and situate and recorded
in the Gambrius Mining District
County of Boise Territory of Idaho.

II

That its principal place of business
shall be in Hailey Alturas County
Idaho.

III

That the time of its existence

shall be forty nine years from and after the date of its incorporation.


IV- That the number of its Directors shall be three.


V That the name of those who shall be Directors and serve as such officers the first three months and shall manage the concerns of the Company for that time and until their successors are elected and qualified are Robert C Fielder of Hailey Idaho, Andrew J McGowan of Hailey Idaho, W J Galbreath of Idaho City Idaho

VI That the Capital Stock of this Corporation shall be two hundred and thirty thousand dollars, divided into forty six thousand shares (46000) of the par value of five dollars each.
