4 The undersigned, acting as sole incorporator of a
5 corporation under the Idaho Business Corporation Act, adopt the
6 following Articles of Incorporation for such corporation:

7 ARTICLE I

8 NAME. The name of the corporation is, J M N, INC.

9 ARTICLE II

10 DURATION. The period of its duration is perpetual.

11 ARTICLE III

12 PURPOSE. The purpose for which the corporation is
organized is:

- 13 1. To engage in a general farming and farm operation
14 business.
15 2. To engage in the transaction of any and all other lawful
16 business for which corporations may be incorporated under the pro-
visions of Chapter I, Title 30 of the Idaho Code or any amendments or
supplements thereto.
