ARTICLES OF INCORPORATION

OF THE STATE OF

SHOSHONE GLASS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is SHOSHONE GLASS, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the operation of a wholesale and retail glass manufacturing, sales and installation, and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 250,000 shares of common stock with a par value of One Dollar (\$1.00) per share.


