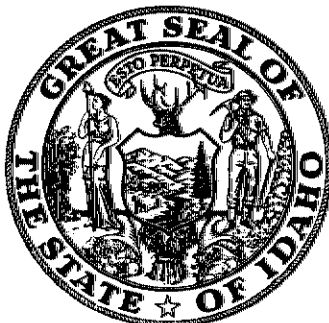

of

The following Articles of Incorporation are hereby
adopted pursuant to the Idaho Business Corporation Act:

1. Name.




