ARTICLES OF INCORPORATION  
OF  
WOOD FUNERAL HOME, LTD.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Wood Funeral Home, Ltd.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized includes: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is \$50,000.00 shares at \$1.00 per share.
