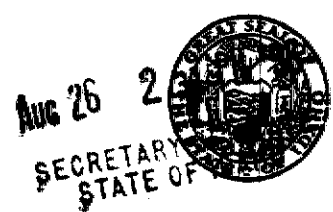

**ARTICLES OF ORGANIZATION**  
**OF**  
**PENTACLE BROADCASTING, L.L.C.**

Pentacle Investments, Inc., a corporation, adopts the following Articles of Organization for a limited liability company under the Idaho Limited Liability Company Act:

**ARTICLE I**

The name of the limited liability company, referred to in these Articles as the "Company" is **PENTACLE BROADCASTING, L.L.C.**

**ARTICLE II**

The address of the Company's principal place of business in Idaho is 1525 Main, St. Maries, Idaho 83861.

**ARTICLE III**

The company shall dissolve on June 30, 2026.

**ARTICLE IV**
