That we, the undersigned, all citizens of the United States of America, of legal age, have this day voluntarily associated ourselves together, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Laws of the State of Idaho, and

We do hereby certify:

FIRST: The name of the Corporation shall be "Childrens' Memorial Foundation

Individuals requesting information of the said corporation's articles, by-laws, or annual financial information will have requested information sent to the individual upon the individual paying for the printing and mailing costs of the requested material.

assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the United States Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principle office of the corporation is then located, exclusively, for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in ARTICLE THIRD hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing of distribution of statements) any political campaign on behalf of or in opposition to any canadiate for public office. Nothwithstanding

any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation. The said corporation will not in any way engage in any activity or exercise any powers that will cause the said corporation to lose its non-profit, tax exempt status with the United States Internal Revenue Service.

NINTH: The management of the corporation shall be vested in a board of not less than three directors as may be fixed by the By-Laws. Additional directors shall be elected at the annual meeting of the corporation's president, vice-president, secretary, and treasurer, to be held at the general office of the corporation in Rexburg, Idaho, unless at a different place designated by the Board of Directors, at a time in each year to be designated by the By-Laws, and until such election, the directors of said corporation shall be: Marilynn Thomason, Lolita Shirley, Gwili Saurey, with the said Marilynn Thomason as president, Lolita Shirley as vice-president-treasurer, and Gwili Saurey as secretary.

TENTH: The By-Laws of this corporation may be adopted by the directors of this corporation in the manner provided for by the laws of the State of Idaho.
