KNOW ALL MEN BY THESE PRESENTS:

THAT THE INCORPORATOR, JOHN HORNER, a citizen of the United States of America, does form a corporation under and pursuant to the laws of the State of Idaho, and does hereby certify as follows:

# <u>FIRST</u>

The name of the proposed corporation is H & K, Inc.

# SECOND

The purposes for which this corporation is formed are as follows:

- a. Principally to engage in the business of renting boats and associated buying, selling, producing, manufacturing and disposing of products associated with this rental business.
- b. To engage in general business associated with the principal business outlined above.
- c. In addition thereto to engage in any or all lawful business for which corporations may be organized under the Idaho law concerning business for profit corporations and which is permitted by the laws of the State of Idaho.

That the capital stock of this corporation shall consist of Twenty Thousand shares of common stock having a par value of Ten Dollars (\$10.00) per share and an aggregate par value of Two Hundred Thousand Dollars (\$200,000.00).
