Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

**FIRST:** The name of the corporation is SANDPIPER INVESTMENTS, INC.

**SECOND:** The following amendments to the Articles of Incorporation were adopted by the sole shareholder of the corporation on February 23, 1988, in the manner prescribed by the Idaho Business Corporation Act:

**"FIRST**

"The name of the corporation is ENCORE INVESTMENTS, INC."

**THIRD:** The number of shares of the corporation outstanding at the time of such adoption was 10,500; and the number of shares entitled to vote thereon was 10,500.

**FOURTH:** The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows:
