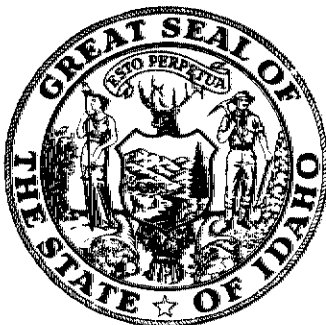

**ARTICLES OF INCORPORATION**

The undersigned, in order to form a corporation pursuant to Idaho Business Corporation Act, certify as follows:

**ARTICLE I**

The name of the corporation is PERFORMANCE HORSESHOEING, INC.  
(hereafter "Corporation").
