ARTICLES OF INCORPORATIONSECRETARY OF STATE OF KESCO ELECTRIC, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Corporation Act, adopt the following Articles of Incorporation for this Corporation.

- I. The name of this corporation shall be Kesco Electric, Inc.
- II. The period of existence and duration of the life of this corporation shall be perpetual.
