ARTICLES OF INCORPORATION K&M INDUSTRIES, INC.

I.

I, the undersigned, being a natural person of age and a citizen of the United States, or its territories or possessions, do hereby voluntarily associate for the purpose of forming a corporation under the laws of the State of Idaho.

II.

The name of the corporation shall be K&M Industries, Inc.

III.

The period of its duration shall be perpetual.

IV.

The location and post office address of the registered office of this corporation shall be 510 S. Main, P. O. Box 66, Troy, Idaho 83871. The registered Agent for said corporation shall be Keith Lunders.

V.

The purposes for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

VI.

The stock to be issued by this corporation shall be common stock. The total number of shares authorized to be issued shall be (1,000,000) one million shares of common stock with a \$.10 par value, and the holders and the owners thereof shall have and acquire such voting rights in said corporation as provided by the laws of the State of Idaho.

Board of Directors of the Corporation, which may consist of money or property or services performed, without any consent or approval of shareholders, whether prior or subsequent.

All shares issued by the Board of Directors pursuant to the authority herein conferred shall be deemed fully paid and non assessable upon the payment or supplying of the consideration for which the Board of Directors shall have resolved to issue such shares; and the judgment of the Board of Directors as to the value of any property or of any service received or resolved to be received in exchange for an issuance shall, in the absence of fraud or bad faith, be conclusive upon all persons.
