



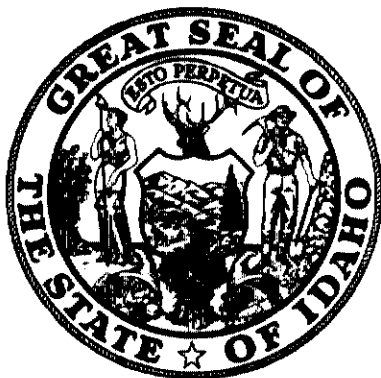
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

OF

WEST VALLEY WOODWORKS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

**NAME:** The name of the corporation is WEST VALLEY WOODWORKS, INC.

ARTICLE II

**DURATION:** The period of its duration is perpetual.

ARTICLE III

**PURPOSES:** The purposes for which the corporation is organized are:

1. To engage in the business of preparing, processing, and otherwise manufacturing and purchasing, trading, and dealing in, for resale, millwork and cabinet shop products composed in whole or in part of wood or wood products.

2. To engage in the transaction of any or all other lawful business for which corporations may be incorporated under the provisions of Chapter 1, Title 30 of the Idaho Code and any amendments thereto.

ARTICLE IV

**STOCK:** The aggregate number of shares which the corporation shall have authority to issue is 25,000. Said stock shall be of one class designated as common stock with a par value of \$10.00 per share.

ARTICLE V

**PREEMPTIVE RIGHTS:** There are no provisions denying preemptive rights.
