The undersigned, in order to form a corporation pursuant to Idaho Business Corporation Act, certify as follows:

**ARTICLE I**

The name of the corporation is Preferred Lawn and Maintenance, Inc. (hereafter "Corporation").

**ARTICLE II**

The purposes for which this Corporation is organized are as follows:

1. To engage in the operation of a yard care and maintenance service; and
2. To engage in any other lawful activity or business for which corporations may be incorporated under the Idaho Business Corporation Act.

**ARTICLE III**

The Corporation shall have perpetual existence.

**ARTICLE IV**

The address of the initial registered office of the Corporation shall be 912 E Twin Willow Court, Boise, Idaho, 83706, and the name of its initial registered agent at such address is Tris Miller.

**ARTICLE V**

The shares of stock to be issued by the Corporation shall consist of one class only, and the aggregate number of shares which the Corporation shall be authorized to issue shall be 1,000 shares of stock, each having a par value of \$1.00 per share. All shares of stocks shall be the same rights in such Corporation and shall be nonassessable when paid in full.


## ARTICLE VII


