# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF THE SENIOR CITIZENS OF THE POST FALLS AREA OF KOOTENAI COUNTY, INC.

Idaho Non-Profit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is: SENIOR CITIZENS OF THE POST FALLS AREA OF KOOTENAI COUNTY, INC.

SECOND: A quorum being present, the following amendments to the Articles of Incorporation were adopted by a majority vote of the members who were present at a special meeting of the membership held on the 6th day of November, 1985 in the manner prescribed by the Idaho Non-Profit Corporation Act.

The original Articles of Incorporation were amended by adding thereto three (3) new articles as follows:

#### ARTICLE X.

This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

#### ARTICLE XI.

Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code.

#### ARTICLE XII.

Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the

1	remaining assets shall be distributed to a non-profit fund, foundation, or corporation which has
2	established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.
