ARTICLES OF INCORPORATION AM 9 09

OF SECRETARY OF PAINT & SUPPLY, INC. TATE

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is PAINT & SUPPLY, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

- 1. To manufacture, produce, prepare, compound, import, export, buy, sell, handle, distribute, and generally trade and deal in and with, at wholesale and retail, paints, paint pigments, varnishes, lacquers, oils, colors, stains, enamels, veneers, polishes, graphite, lead, and other minerals and ores of all kinds, cement, mixtures, compounds, waterproofing, fireproofing, and chemical compounds and products of all kinds, painters' supplies and equipment of every kind and description, and similar articles, substances, and products of every kind and character, for any and all purposes.
- 2. To transact any and all lawful business for which corporations may be incorporated under the laws of the State of Idaho.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is fifty thousand (50,000) shares of the par value of One Dollar (\$1.00).

FIFTH: The address of the initial registered office of the corporation is 6517 Ustick Rd., Boise, Idaho 83704,
