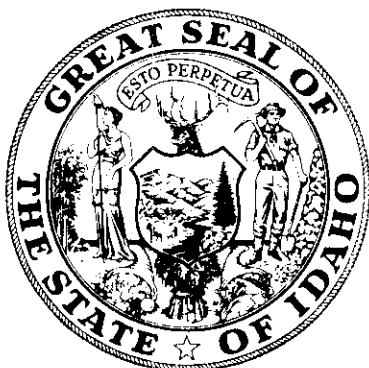

ARTICLES OF INCORPORATION

OF

D.M. / D.M.R., ARCHITECTS, P. A.

We, ORION DOUGLAS CRANSTON, MONTE J. MILLER, MORITZ KUNDIG and RON TAN, being of legal age and duly licensed under the provisions of Title 54, Chapter 3, Idaho Code, to practice architecture as therein defined in the State of Idaho, for the purpose of forming a professional service corporation pursuant to Title 30, Chapter 13, Idaho Code, do hereby certify:

ARTICLE I.

That the name of this corporation shall be:

"D.M. / D.M.R., ARCHITECTS, P. A."

ARTICLE II.

That the duration and existence of this corporation shall be perpetual.

ARTICLE III.

That the purposes of this corporation as formed are as follows:

To engage in every phase and aspect of rendering the same professional services to the public that an architect duly licensed under the laws of the State of Idaho, is authorized to render; that such professional services shall be rendered only through individuals authorized by the laws of the State of Idaho.

To invest the funds of the corporation in real estate, mortgages, stocks, bonds or any other type of investment and to own real and personal property necessary for the rendering of professional services.

To do everything necessary and proper for the accomplishment of any of the purposes and all other acts permitted by applicable laws of the State of Idaho.

ARTICLE IV.

That the location of the office of this corporation shall be 411 Front Avenue, Coeur d'Alene, Idaho, and its registered agent at that address shall be ORION DOUGLAS CRANSTON.

ARTICLE V.

That the total authorized stock of this corporation shall be 25,000 shares at \$1.00 par value each, all of one class which shall be designated common stock.
