ARTICLES OF INCORPORATION

FOR

FRIENDS OF THE GARDEN VALLEY LIBRARY, INCORPORATED

ARTICLE I

NAME

The name of this organization shall be the FRIENDS OF THE GARDEN VALLEY LIBRARY, INCORPORATED.

ARTICLE II

PURPOSES

It is recognized that the GARDEN VALLEY LIBRARY is a public library, administered by the Garden Valley District Library Board of Trustees.

The purpose of this organization shall be to assist the GARDEN VALLEY PUBLIC LIBRARY in maintaining an association of persons interested in books and libraries; focusing public attention on library services, facilities and needs; and in stimulating gifts of books, magazines, desireable collections, endowments and bequests.

ARTICLE III

MEMBERSHIP

Section 1. Membership in this organization shall be open to all individuals in sympathy with its purposes, and to representatives of organizations and clubs when such representation is desired, in which case dues shall be paid by the organization.

<u>Section 2</u>. Each organization and individual member shall be entitled to one vote.

ARTICLE IV

ADDRESS - AGENT

The address of the organization for initial registration is Garden Valley Library, Garden Valley, Idaho 83622. The name of its initial registered agent at such address is Jeri Brown, Librarian.

ARTICLE V

DIRECTORS

The initial board of directors is hereby designated as the officers of the organization, plus its immediate past president, constituting five(5) directors as follows:

Twila Bechtold, president; Ida M. Reinig, vice-president; Dorothy Pitman, secretary; E. Kliess Brown, treasurer; and Sylvia Ross, immediate past president, all with address: Garden Valley, Idaho 83622.

In accordance with Section 30-314(c) of the Idaho Code, the affairs of the corporation shall be managed by its membership, with its board of directors serving as the executive committee of the organization.

ARTICLE VI

NONPROFIT STATUS

The Friends of the Garden Valley Library, Incorporated, shall be and is hereby established as a nonprofit corporation on a perpetual basis.
