



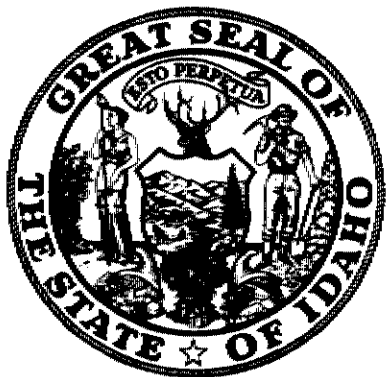
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

OF

KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned, being natural person of full age and a citizen of the United States, in order to form a corporation for the purposes herein-after stated, pursuant to the Business Corporation Act of Idaho, do hereby certify as follows:

ARTICLE I

The name of the corporation is K & B CONSTRUCTION, INC.

ARTICLE II

The objects and purposes for which this corporation is formed and the powers of such corporation are as follows:

1. To engage in any commercial, industrial, or agricultural enterprise calculated or designed to be profitable to this corporation, and in conformity with the laws of the State of Idaho.

2. To engage in the business of erecting buildings, agricultural structures, commercial structures, private structures, or perform improvements or repairs to the above in conformity with the laws of the State of Idaho.

ARTICLE III

The period of its duration is perpetual.

ARTICLE IV

The corporation is organized for the purposes of conducting and transacting any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE V

The aggregate number of shares which the corporation shall have authority to issue is 50,000 shares and shall have no par value.

ARTICLE VI

Provisions for the regulation of the internal affairs of the corporation are as shall be set forth in the By-Laws of the corporation as from time to time be adopted or amended.

## ARTICLE VII

The address of the initial registered office of the corporation Rt. #3, Box 3002, Parma, Idaho 83660, and the name of its initial registered agent at such address is Brian S. Dougherty.

## ARTICLE VIII

The number of directors constituting the Board of Directors of the corporation is one or such greater number not to exceed four as shall be fixed by the By-Laws. The name and address of the person who shall serve as initial Board of Directors until the first annual meeting of shareholders or until his successor is elected and shall qualify is:

The hereinbefore named director constituting the Board of Directors shall also be the incorporator, having total and equal rights and privileges as constituted for an incorporator as stated by the laws of the State of Idaho. He is Brian S. Dougherty of Parma, Idaho.

## ARTICLE IX

The directors of the corporation have the power in their discretion to reserve from the profits each year the amount thereof as they may deem necessary and advisable for the purpose of establishing a reserve fund to be used as working capital in the business of the corporation, and they may employ and use such funds for the purpose of the corporation or to purchase its own stock, or to purchase stocks, bonds, or other obligations of other corporations which it is authorized by the law to purchase.

## ARTICLE X

At all meetings of shareholders including adjourned meetings, the presence in person or by proxy of holders of fifty-one percent (51%) of the outstanding shares entitled to vote shall constitute a quorum.

## ARTICLE XI

Each holder of shares of this corporation shall have the first right to purchase shares of this corporation that from time to time be issued, in the ratio that the number of shares he holds at the time of issue bears to the total number of shares he holds at the time of issue bears to the total number of outstanding exclusive of treasury shares.


