We the undersigned, desiring to form a non-profit corporation under the statutes of the State of Idaho, do hereby make, subscribe, and acknowledge as follows:

ARTICLE ONE

NAME

The name of the corporation is MELBA REBEKAH LODGE NO. 105 INDEPENDENT ORDER OF ODD FELLOWS, INC.

ARTICLE TWO

NON-PROFIT PURPOSE

This corporation is organized exclusively for operating a fraternal lodge for social, benevolent and charitable purposes within the meaning of Section 501 (c))3) of the Internal Revenue Code. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code. No part of the corporate assets, income, or profit shall be distributable to, or inure to the benefit of its officers, trustees, or members except to the extent permitted for a non-profit corporation under the non-profit corporation laws of the State of Idaho and under the non-profit corporation laws of the State of Idaho and under the non-profit corporation laws of the Internal Revenue Code. 19940207 0900 53361 2 CM 8: 1868 CUST 28950

The Corporation shall not take steps which serve to facilitate the transaction of specific business by its officers, trustees, or members; or promot e the private interest of any officer, trustee, or member; or engage in any activity which would constitute a regular business of a kind ordinarily carried on for profit.

The period of duration of this corporation is perpetual.

ARTICLE FOUR
