ARTICLES OF INCORPORATION OF ROCKY MOUNTAIN ASSOCIATES, ECING. STATE

The undersigned natural person of the age of twenty one years or older, acting as an incorporator of Rocky Mountain Associates under the Idaho Code, adopts the following Articles of Incorporation:

ARTICLE I

The name of this corporation is Rocky Mountain Associates, Inc.

ARTICLE II PURPOSES AND DURATION

The purpose of the corporation is to engage in the business of consulting for airport planning, design and management and to engage in any other lawful act or activity for which corporations may be organized under the General Business Corporation Act of the State of Idaho. The period of duration of the corporation shall be perpetual.

ARTICLE III CAPITALIZATION

This corporation shall have authority to issue 1,000 shares of Common Stock. Each share of Common Stock shall have a par value of \$0.001. All shares of Common Stock shall have the same rights and preferences. Fully paid stock of this Corporation shall not be liable to any call and is non-assessable.

ARTICLE IV ELIMINATION OF PERSONAL LIABILITY OF DIRECTORS

The directors of the corporation are not liable to the corporation or to its stockholders for monetary damages for breach of fiduciary duty as a director, except liability:

- (a) for any breach of the director's duty of loyalty to the corporation or its stockholders;
- (b) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law;
 - (c) provided for under Section 30-1-48, Idaho Code; or

(d) for any transaction from which the director derived an improper personal benefit.

ARTICLE V PREEMPTIVE RIGHTS

The corporation elects to have preemptive rights for all Common Stock.

ARTICLE VI CUMULATIVE RIGHTS

The shareholders shall have the right to cumulate their shares when electing directors of this corporation.
