



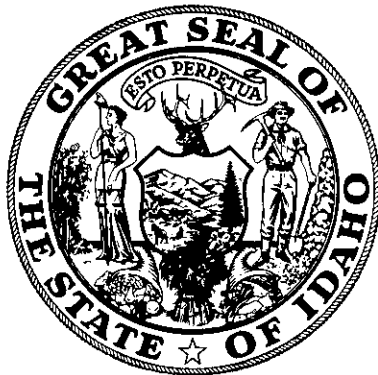
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

OF

JET BOAT SALES, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME. The name of the corporation is, JET BOAT SALES, INC.

ARTICLE II

DURATION. The period of its duration is perpetual.

ARTICLE III

PURPOSES. The purposes for which the corporation is organized are:

1. To manufacture and sell boats and boat trailers.
2. To engage in the transaction of any or all other lawful business for which corporations may be incorporated under the provisions of Chapter 1, Title 30 of the Idaho Code and any amendments thereto.

ARTICLE IV

STOCK. The aggregate number of shares which the corporation shall have authority to issue is 5,000. Said stock shall be of one class designated as common stock with a par value of \$100.00 per share.

ARTICLE V

PREEMPTIVE RIGHTS. There are no provisions denying preemptive rights.

ARTICLE VI

INTERNAL AFFAIRS. There are no provisions for the regulation of the internal affairs of the corporation.

ARTICLE VII

1 REGISTERED OFFICE AND REGISTERED AGENT. The address of

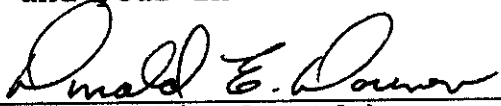
