ARTICLE I.

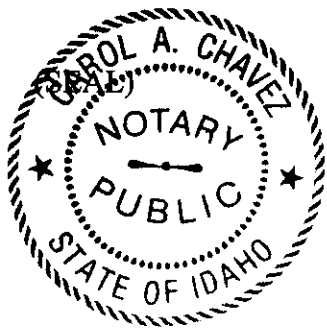
