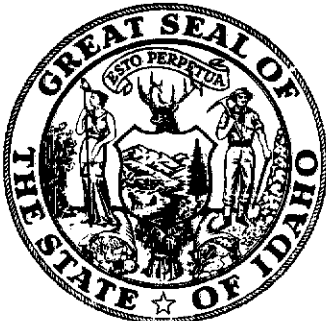

ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporations Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is **Wade Harris Trucking, Inc.**

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: To conduct any lawful business authorized by the provisions of the Idaho Business Corporations Act.

FOURTH: The aggregate number of shares which the Corporation shall have authority to issue is 1,000, no par value.

FIFTH: Provisions denying preemptive rights are: None.


