a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the **Eighth** day of **February**, 19 63, original articles of amendment, as provided by Section 30-146, 30-147 and 33-3905, Idaho Code, providing that a majority of the Board of Trustees shall always be members of the Presbyterian Church in the United States of America,

and that the said articles of amendment contain the statement of facts required by law, and are recorded on Film No.

122 of Record of Domestic Corporations of the State of Idaho.

I THEREFORE FURTHER CERTIFY, That the Articles of Incorporation have been amended accordingly.

CERTIFICATE OF AMENDMENT TO ARTICLES OF INCORPORATION

at least two-thirds (2/3) of the Trustees of The College of Idaho, a corporation, do hereby certify that Paragraph Second of the Articles of Incorporation of The College of Idaho, adopted on the 1st day of April, A.D. 1893, be, and the same hereby is amended by providing that instead of two-thirds (2/3) of the members of the Board of Trustees shall always be members of the Presbyterian Church in the United States of America, it shall provide that a majority of the members of the Board of Trustees shall always be members of the United Presbyterian Church in the United States of America, so that the Third Amended Articles of Incorporation of The College of Idaho shall be and hereby are amended to read as follows:

"Second. That the purposes for which the corporation is formed are to found, establish and maintain an institution of learning to be owned and under the control of a Board of Trustees, a majority of whose members shall always be members of the United Presbyterian Church in the United States of America; and to take by purchase, gift, grant, devise or bequest, and to hold the same for the use of such corporation, any real or personal property whatsoever, and to sell, convey, mortgage or otherwise use the same as may be considered most conducive to the interests of such institution,

so that the Third Amended Articles of Incorporation of The College of Idaho shall be and hereby are amended to read as follows:

FOURTH AMENDED ARTICLES OF

INCORPORATION OF THE COLLEGE OF IDAHO.

"Know all men by these Presents, that we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho.

"And we hereby certify:

"First. That the name of said corporation is The College of Idaho.

"Second. That the purposes for which the corporation is formed are to found, establish and maintain an institution of learning to be owned and under the control of a Board ofTrustees, a majority of whose members shall always be members of the United Presbyterian Church in the United States of America; and to take by purchase, gift, grant, devise or bequest, and to hold the same for the use of such corporation, any real or personal property whatsoever, and to sell, convey, mortgage or otherwise use the same as may be considered most conducive to the interests of such institution.

"Third. That the place where such institution is to be located is Caldwell, Canyon County, Idaho.

*Fourth. That the number of Trustees shall be thirty, besides the President of the Institution who shall be ex-officio a member of the Board of Trustees. The term of office of such Trustees and the manner of their election shall be provided by the By-Laws."
